**The HSYAC is open to any Michigan flutist in grades 9–12 who has not previously won the first prize. The applicants must be available to perform at the Southeast Michigan Flute Association (SEMFA) Festival in Detroit, Michigan on November 12, 2016.**

Six finalists will be selected on the basis of recorded auditions. Judges will award, at their discretion, first, second and third cash prizes in the amounts of \$300, \$200 and \$100. The First Prize winner will perform in a masterclass for George Pope, our featured guest artist at the 2016 SEMFA Festival.

<p><b>REPERTOIRE</b></p> <p><b>Recorded Preliminary Round</b> <i>Maximum length not to exceed 15 minutes.</i> <i>Please record movements of multi-movement works as separate tracks.</i></p> <ol style="list-style-type: none"> <li>1. One piece of your choice. Accompanied works must be recorded with accompaniment</li> <li>2. No. 3 OR No. 4 of Astor Piazzolla's Tango Etudes</li> </ol> <p><b>Final Round</b> <i>Repertoire for the program not to exceed 15 minutes.</i> <i>You may use the edition of your choice.</i> Live: Six (6) finalists will be chosen. Same repertoire as Preliminary Round. Performance should not exceed 15 minutes.</p> <p><b>Considerations</b></p> <ul style="list-style-type: none"> <li>• Previous first place winners of the HSYAC are ineligible for this competition.</li> <li>• The final round is open to the public.</li> <li>• Finalists must provide their own accompanist.</li> <li>• Finalists agree to appear at the SEMFA Festival at their own expense.</li> </ul>	<p><b>To Apply</b></p> <ol style="list-style-type: none"> <li>1. Prepare two (2) <u>UNEDITED</u> HIGH QUALITY copies of your performance on CD or an mp3. Edited recordings will be disqualified.</li> <li>2. Pay \$30 non-refundable application fee (along with \$10 (student) SEMFA membership dues if you are not currently a SEMFA member) by check or PayPal.</li> <li>3.
