

Southeast Michigan Flute Association
Annual Ervin Monroe Young Artist Competition
April 27-28, 2012

Eligibility: The EMYAC is open to any current SEMFA member who is a permanent resident of Michigan or is a student at a Michigan college or university. Applicants must be 18–30 years of age by April 27, 2012, the date of the Ervin Monroe Young Artist Competition. The applicants must be available to perform at the SEMFA Festival in Ann Arbor the following day, April 28, 2012. Previous first prize winners are not eligible to compete.

Rules: Application must be postmarked or emailed by Monday, March 5, 2012. There will be a \$15 fee for late entries if they are accepted. Dues may be enclosed with application. Membership dues are non-refundable. The application fee of \$35, made payable to SEMFA, will be refunded only if the cancellation is received on or before March 5. Fees and dues may also be paid electronically.

All applications must include:

- A completed application form.
- An **unedited** digital recording of the required repertoire (either CD or mp3). The recording must not include any identifying information. CDs should not be labeled, and recordings should not include any speaking. Recordings will be coded and reviewed by a judging committee.
- Your \$35 application fee
- Your membership dues, if not previously paid (membership year runs January – December).

Five finalists will be notified by March 15, 2012. Judging is based on technical proficiency, musical style, and interpretation. All judges decisions are final.

Contestants must provide their own accompanist for the final round. The final round is open to the public. Finalists agree to attend the Flute Festival at their own expense.
